She has a rich experience of 15 years dealing in cases pertaining to Matrimonial Litigation, Domestic Violence, Muslim Law, etc. She represents litigants in Family Courts, District Courts, Magistrates Courts, Sessions Court across Mumbai, Thane, Navi-Mumbai. She takes up cases at the High Court at its Original and Appellate Jurisdiction. She has been conducting trainings for the State and Non-State Stake Holders under the Domestic Violence Act and Muslim Women Act across Maharashtra. At present, she is a mentor and a consultant to a team of lawyers at Lucknow and Ranchi. She is a member of WICCI Maharashtra. She is also an external committee member under the Sexual Harassment at Workplace Act.



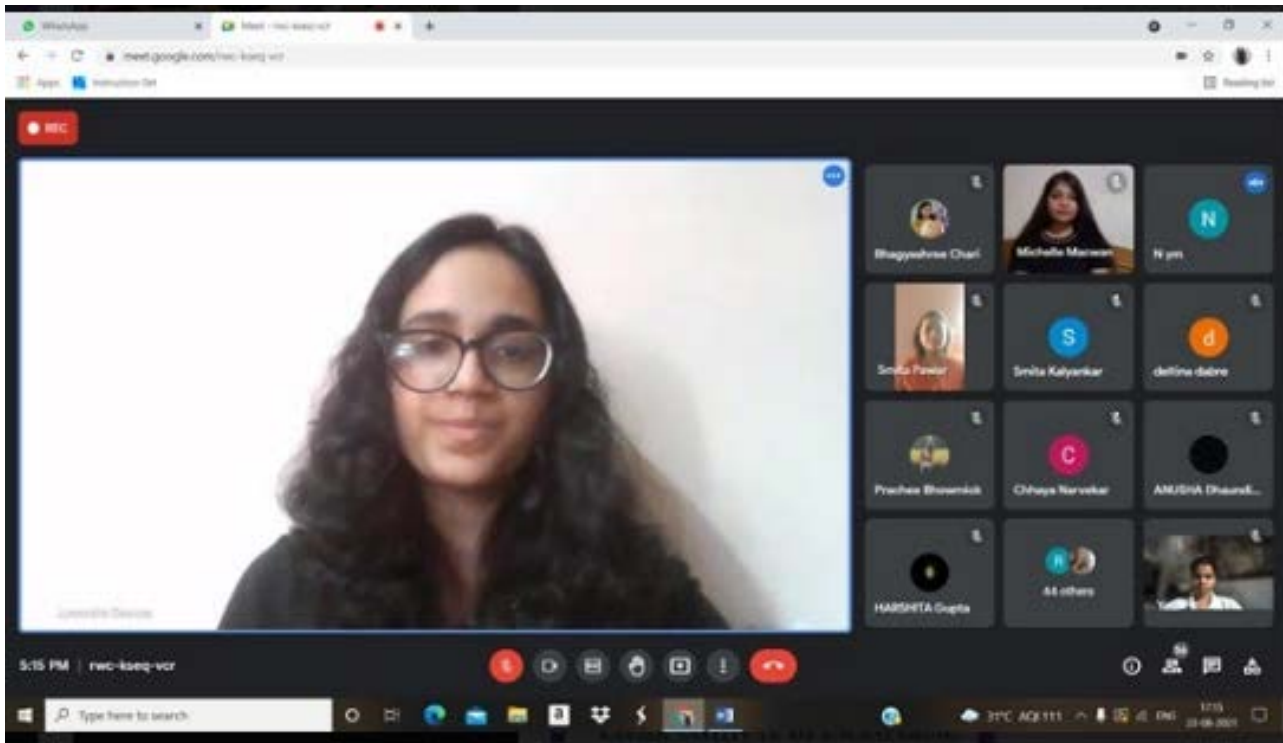

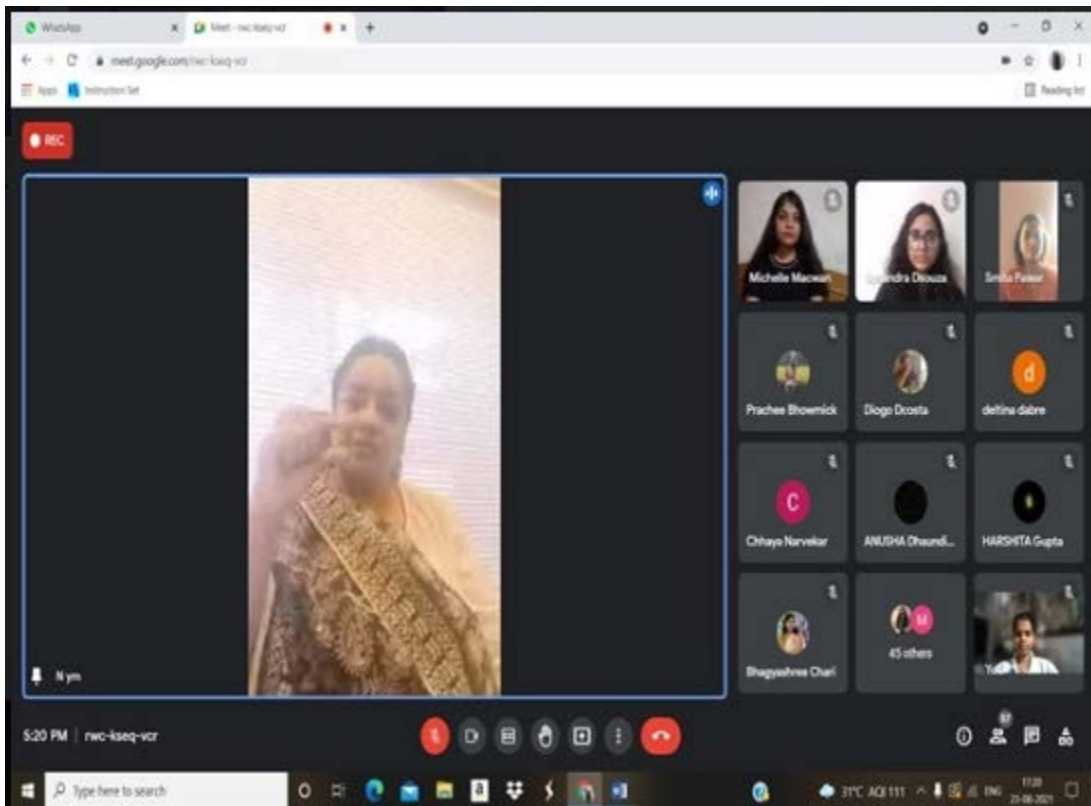
